NDDH Board of Directors Meeting Minutes Date: September 10, 2020 – 3:00 PM

Reports from Board Members on Town's Satisfaction with NDDH Services -

- L. Thurlow, Canterbury: Canterbury is satisfied with our services and he will let us know if any issues arise.
- E. Lippke, Danielson: Danielson is satisfied with our services, she will report any issues that come up in the future.
- P. Torcellini, Eastford: Paul recognized Sue for her help with reopening the schools in Eastford. He stated there are issues for who oversees compliance with wells and septic when clients are noncompliant.
- B. Grindle, Hampton: Hampton appreciates NDDH efforts to get information out. The material we distribute, and information we put out also helps explain to other Boards what it is we do.
- D. Griffiths, Killingly: Online NDDH services had a learning curve, but are improved. Killingly has a concern for the timeframe of septic approvals. Otherwise, NDDH is doing extremely well.
- D. Gladding, Plainfield: Plainfield is happy for the most part with NDDH. They have had several COVID related complaints to the town. Suggesting that when guidance is issued, it should also be said who oversees what part of it.
- A. Hinchman, Pomfret: She has reached out to her town's elected official but has not heard back. She plans to attend a selectman's meeting to open communication.
- L. Salisbury, Sterling: Sterling, like all towns, is struggling with opening schools and opening services. The town is thankful that NDDH work does not require further work for them and there has been no Facebook complaints about NDDH. She will possibly attend a selectman's meeting.
- O. McKiernan-Raftery, Thompson: She spends lots of time in the town hall and has had positive feedback from conference calls with other agencies/groups. She has not heard any complaints.
